- **Stakeholder consultation on the Bio-waste** - The Commission adopted on 18 May 2010 a Communication on future steps in bio-waste management in the European Union (COM(2010)235 final). This Communication includes an analysis of the bio-waste management options in the EU and outlines further actions in this area. Increased composting and anaerobic digestion were identified as two options where potential benefits appear to be significant. However, due to the different conditions in Member States, it was estimated that further work was needed, notably from the subsidiarity perspective, before considering proposing an EU target for biological treatment. The Commission committed itself to continue an analysis on the appropriateness of setting such targets by 2014 at the latest under the Waste Framework Directive.
